

### Contest guidelines

### Terms and conditions

1. You have to be a Starlight registered family

3. You have to raise a minimum of \$100 to be entered in the draw. The more you raise the more chances you have of winning the trip. Should you raise \$400 and you have 4 chances of winning, raise \$1,500 and you have 15 chances of winning, etc.
4. Cheque or cash donations made towards your family's page are accepted for entry in the draw. All offline donations must be received by December 19<sup>th</sup>, 2019 by 4:30pm to be eligible.
